Meet the candidates

SHARICE DAVIDS-(Democrat) U.S. House of Representatives, District 3

Sharice Davids was raised by a single mom who served over 20 years in the US Army. A proud graduate of Leavenworth High School, she was the first in her family to attend college. Sharice worked her way from Johnson County Community College to Cornell Law School, juggling multiple jobs to put herself through school. She received the state press association's Boyd Award for Community Service for The Garden City Telegram's part in raising awareness of problems at the local animal shelter, with her editorials calling for a new shelter that currently serves the community. She also was honored with the Clyde M. Reed Jr. Master Editor Award given for a lifetime of achievement that involves commitment to community, the Kansas newspaper industry and the state. Sattler now works from her home in Topeka as a freelance writer and consultant for organizations throughout Kansas. She's a trustee for the Kansas Newspaper Foundation and the William Allen White Foundation at the University of Kansas. Sattler also served as a board member for the Garden City Area Chamber of Commerce, Garden City Downtown Vision, Big Brothers Big Sisters of Finney and Kearny Counties, the Finney County Humane Society and Franklin County Habitat for Humanity. She currently is secretary of the Friends of Ted Ensley Gardens board of directors in Shawnee County. Sattler is a graduate of the University of Iowa, and an honorably discharged veteran of the U.S. Army Reserve and Iowa National Guard. She received the National Defense Service Medal, established by President Dwight D. Eisenhower, for her service during the First Gulf War. She and her husband, Ed, a retired design engineer, live near Lake Shawnee in Topeka with her mother, Ruth Ann, and rescue dog, Ellie.

CARRIE BARTH - (Republican); Kansas House of Representatives, District 5

Politicians should never come between a medical provider and patient. I support Medicaid expansion in Kansas, for the working poor, to bridge the gap between those who qualify for Medicaid and those who can afford health insurance. I support a fair tax plan that will support growth and still bring noticeable relief to Kansans. I feel that restarting the Local Ad Valorem Tax Reduction Fund(LAVTRF), a program that worked well from 1937 until it was stopped in 2003 and then killed in 2024, to return State tax dollars to the counties and help keep property taxes down. Public dollars for public schools. Ensuring our schools are fully funded and teachers fairly treated. Kansas teacher's retirement plan is ranked 35th in the nation. Kansas legislators have a plan ranked 3rd in the nation. Our K-12 education is ranked 24th in the nation. We can do better. Public schools and education are one of the foundations of our nation. I believe as Kansans, there is more that unites us than divides us. It is always possible to find common ground.
