2024 PARADE GUIDELINES

Thank you for your interest in the 80th Annual Santa Parade in Rockford. The parade will be held on Saturday, December 7, 2024 at 11am.

Please review the following guidelines before completing and returning the application.

- **MANDATORY SAFETY MEETING:** Tuesday, December 3, 2024 | 6:00pm | Rockford United Methodist Church. ALL parade applicants are required to have a representative at the Mandatory Safety Meeting. Entries who do not attend will not be able to participate in the Santa Parade.
- **LINE UP & CHECK-IN:** You will receive your line up number via email the week prior to the Safety Meeting. Further instruction on check-in will be provided at the Safety meeting as well.
- **PAPER & HANDOUTS:** This is a family-friendly event. If you want to hand out items at the parade, they must be geared towards children. NO paper hand outs are allowed!! Only walkers are able to distribute candy – Absolutely no candy may be thrown from a vehicle!
- **GROUPS:** Please relay all guidelines and information regarding the parade to everyone in your group. Any groups/entries who do not follow guidelines presented here and at the Safety Meeting will forfeit participation in future parades.
- **DESIGNATED QUIET ZONE:** There will be a designated Quiet Zone that stretches from Tamarack Run to Lewis Street. This Zone means there is no music, sirens or other loud noises. We will have signage at the parade as a reminder.
- **DEADLINE:** All parade applications must be received by Friday, November 15, 2024. Any applications received after this date will not be eligible to participate.
