

# **Census Will Confirm Growth**



The information gathered from the census will impact funding for roads, schools, hospitals and much more. Census data is used to determine



how to distribute more than \$400 billion each year to states and communities like Grand Forks and East Grand Forks.

Questionnaire Assistance Centers will be located at the Grand Forks Public Library, the Chester Fritz Library at UND, the Greater Grand Forks Senior Citizen Center and the Grand Forks County Office building.

## President's Message Chamber Update

Mayor Cites Chamber/City Partnerships During State of the City Grand Forks Mayor Michael Brown delivered a very positive message to a huge crowd of 350 people during his Chamber sponsored State of the City Address recently. He talked about our many community assets, resources and opportunities.

From a business community perspective, he mentioned 13 specific items where the Chamber and City are working together, providing evidence that the City and Chamber are partnering more than ever before to get things done. Some of the things we are working on are reducing retail leakage, future missions at the base, city regulatory issues like the downtown design review guidelines and developing a joint "community wide" agenda for the 2011 legislative session.

Library Feasibility Discussed Library Board Chairman, Susan Mickelson, from Simmons Flint, and Library Executive Director, Wendy Wendt spoke at The Chamber Board of Directors Meeting and Chamber BGEA Committee recently. They presented a very compelling case to replace the existing 1972 Grand Forks Public Library. The need seems apparent. The next phase is to assess the viability of 11 different locations, select an architect and then determine the best approach to funding a Library project. The Chamber will continue to monitor this project keeping in mind the important balance between local taxes the need for quality of life infrastructure.

#### **Chamber Retail Committee Moves to Solution Phase**

At their February meeting, the Retail Committee talked about retail leakage of Northern Valley customers to Fargo, online and beyond. They also reviewed CVB survey data from Canadian visitors showing what would make them more likely to visit again and stay longer in our communities. Selection and variety were near the top of the list.

There are a variety of ways to work with existing business people to fill in these real and perceived gaps in products and services. There are also data sets and tools available for existing and potential new businesses to consider in their decision to diversify, expand or even add a new location in our market. To this end, the retail committee voted to look at potential options to reduce this leakage. At the march 8<sup>th</sup> meeting a retail analytic firm will make a presentation outlining some of the potential options.

Why is this important? Shopping locally helps provide local jobs, helps local business thrive, helps encourage new businesses to open and puts sales tax revenue into local quality of life projects and essential community services.

The Retail Committee will meet at 2 p.m. at City hall in Grand Forks. All interested Chamber members are welcome to attend.





March 20th is National Ag Day and The Chamber's Agribusiness Committee wants you to know.....

Nearly 75% of total USDA Farm Bill Budget goes directly to consumers in the form of assistance to purchase food (EBT) Electronic Benefit Transfers.

## Fun Facts

Americans today consume **17.3 billion quarts of popped popcorn** each year! The average American eats about **68** quarts!

One bushel of corn will sweeten more than 400 cans of pop. There are about 600 kernels on each ear of corn.



Each American consumers, on average, **53 pounds of bread per year**. Assuming a sandwich was eaten for breakfast, lunch and dinner, it would take 168 days to eat the amount of bread produced from one bushel of wheat.
