Show Date: Location: Show Hours: Set-Up Times:	August 6, 2022 - Saturday 1 st Avenue North (on south side of the Courthouse in the grass) in Downtown Estherville 10am-4pm. Booth must remain intact until end of show at 4pm. Set up is from 7-9:45am the morning of the event. You will receive loading instructions with map at a later date.
Spaces:	Booth spaces are 10' deep and 10' long. The cost per booth space is \$40 or \$30 if you are a member of the Estherville Area Chamber of Commerce . Spaces will be assigned based on registrations received by July 15 th , with payment. Confirmation and location of your booth will be sent to you prior to the event. Tents are encouraged but not required – it helps define your space – NO STAKES.
Tables & Chairs:	You will need to provide your own display racks, tables and chairs.
Electricity:	If needed is \$10 (limited spaces – first come, first served).
Registration:	Please fill out the attached form. Deadline is July 15 th . A late fee of \$5 will be required for all registrations received after the July 15 th deadline. A confirmation notice, space number, and a map will be mailed or emailed to you prior to the event.
