## Polk CARES 2020

Polk County's Board of County Commissioners has approved a plan that will help residents and small business owners left struggling financially from COVID-19 pandemic layoffs and business closures.

Recent changes: Doubled the amount of funding in each tier and allows businesses who have received the PPP, EIDL or SBA Debt forgiveness to apply.

In late April, the county received \$126 million from the federal government's Coronavirus Aid, Relief, and Economic Security (CARES) Act grant meant to provide relief to small businesses and residents who were either furloughed or laid off from their jobs. Assistance will help pay for utilities, rent and mortgages, and help small businesses to remain open or reopen. The Board allocated \$40 million for small business economic development needs, \$30 million for health and human service needs, \$30 million for community healthcare related to the coronavirus, and \$26 million for county and local government's costs and services dealing with COVID-19.

Beginning **Tuesday**, **May 19**, individuals and small business owners may apply online. The online application process will require residents and business owners to fill out a form, and attach verifying documentation with the application.

A call center to assist residents with questions regarding Polk County's CARES Act financial assistance will also open on **Tuesday**, **May 19.** Call center staff will be available from 8 a.m. – 6 p.m., Monday - Saturday. The call center telephone number will be published here when it opens.

#### Individuals/Households

Individuals and/or households may apply for rent, mortgage and utility assistance. Individuals who have lost their job or income due to the COVID-19 pandemic, and reside in a household with combined income of less than \$75,000 will be eligible for up to \$2,000 assistance.

On your application, you must confirm that you:

• Have not received other COVID-19 assistance for rent, mortgage or utility payments

## Required Documents:

Valid Florida ID or Florida Driver License

- 2019 Income Tax return or the most recent tax return paystubs for the past 60 days
- Proof of loss of income related to COVID-19 impacts due to health and employment (furlough, lay-off letter from employer, unemployment statement, etc.)
- Utility invoice, and/or mortgage or rent bills

## Small Business

Small businesses that can show they were impacted by COVID-19 include funding levels of \$2,000 for those who are self-employed, \$5,000 for businesses with 2-9 employees, and \$10,000 for businesses with 10-25 employees.

Small business applicants must attest they:

- Were negatively impacted by COVID-19
- Have the authority to apply for this grant on behalf of the business
- Have not received Paycheck Protection Program (PPP); Economic Injury Disaster Loan (EIDL); or benefited from the SBA Debt Relief Program as provided under the CARES Act
- Will use the grant funds for authorized business expenses only
- Will apply for a Polk County Business Tax Receipt if not registered with the Polk County Tax Collector
- Plan to resume normal operations after emergency guidelines are lifted
- Shall cooperate with Polk County or appropriate officials for grant auditing purposes

#### Required Business Documents:

- W-9, DBA, Employer ID Number, or Social Security number for sole proprietors
- Valid photo ID
- Copy of active state business registration from Florida Division of Corporations
- W3 Summary or IRS Form 941 prior to February 15, 2020
- Information to estimate your company's average monthly expenses for wages, business utilities, and commercial lease (or mortgage interest) before February 15, 2020

Both funds will be offered on a first-come, first-serve basis until the allocation is gone. The county has until December 30, 2020 to use this grant. The allocated funds to both small businesses and individuals do not have to be paid back.

As many Floridians do not have access to a computer at this time, Governor DeSantis has instructed DEO to make paper Reemployment Assistance applications available for Floridians.

- FedEx is offering free printing and mailing of Reemployment Assistance paper applications at over 100 storefronts across the state.

Additionally, to make it easier for Floridians to receive Reemployment Assistance, Governor DeSantis waived:

- The waiting week, so individuals can claim their very first week of Reemployment Assistance.
- The work search and work registration requirements so individuals filing for Reemployment Assistance are not required to register in Employ Florida or submit information on a biweekly basis regarding the employers that they contacted each week while the state mitigates the spread of COVID-19.
