GENERAL INFORMATION:

The 2024 Under the Oaks Art Show is open to all two dimensional ORIGINAL works of art by persons 16 or older, no copies will be accepted. Due to exhibiting space no three dimensional work can be accepted in this year's show. Each applicant may submit two entries.

RULES:

All pieces must have an estimated value (insurance) and have to be for sale. The price of the art for sale should include a 15% commission to the Lee County Chamber of Commerce if sold during or as a result of the exhibition.

Hanging work should not exceed 36 inches in width or 36 inches in height including frame (no exception), no saw tooth hangers or clips **MUST HAVE WIRE ONLY. NO POSTER FRAMES.**

Gallery wrapped canvas will be accepted. No piece should be larger or heavier than two people can handle. The Lee County Chamber of Commerce reserves the right to reject works not properly prepared for display.

No fragile work or work requiring installation or lights will be accepted.

All work must *BE ORIGINAL* and have been produced within the last three years. Works previously exhibited at "Under the Oaks" are not to be resubmitted.

PREMATURELY FROM THE EXHIBITION. NO
EXCEPTIONS!*** All works sold must remain in the show until the artists pick up date.

No changes in titles or prices are allowed after entry form is submitted!
